# Moral Action Info On Current Issues

## From Chris Gonthier BMAO Moral Action

The purpose of this article is not to tell you how to vote, but rather to give information to help make decisions.

We will look at State Question No. 833 Legislative Referendum No. 376 and State Question No. 834 Legislative Referendum No. 377.

I know many people vote their choice in primaries, but vote straight party in the general election. Judges in the state of Oklahoma do not have party affiliation, so it may be necessary to do some research.

Citizens will be asked whether or not to retain the three Justices of the Supreme Court. Noma D. Gurich district 3, Yvonne Kauger district 4, and James Edmondson district 7.

If you need to know where to vote, go to Oklahoma voter portal or check your voter ID card.

Okvoterportal.okelections.gov You do need to bring acceptable ID.

The three Supreme Court Justices were appointed by Democrat governors. These judges have the reputation among many to be very liberal activist type judges.

If you want them to continue, you would vote yes. If you wish the opportunity for more conservative justices to be appointed, then vote no.

SQ834...Oklahoma-2024-SJR23-Enrolled.pdf is where to go to see the language of this bill. It is called the Oklahoma Citizenship for Voting Amendment (2024)-(SJR23).

Basically this bill would help ensure

that only citizens of the United States, over the age of 18 who are bona fide residents of this state, are qualified electors of this state.

A yes vote will approve of changes clarifies only US citizens can vote. A no vote will keep the original language.

This is a constitutional amendment so understanding this is very important.

SQ833 Creates "Public Infrastructure District" for Bond debt (SJR16) Against Property owners land! https://oklahoma.gov/content/dam/ok/en/elections/state questions/sq2024/sq833.pdf (SJR16) Oklahoma-2024-SJR16-Enrolled.pdf

This is also a constitutional amendment.

Section 9E.

A. There are hereby created public infrastructure districts.

B. Municipalities may approve the creation of public infrastructure districts, which may incur indebtedness and issue public infrastructure district bonds to pay for all or part of the cost of public improvements within such districts.

The cost of all indebtedness so incurred shall be levied and assessed by the board of trustees of a public infrastructure district on the property benefited by such improvements following the passage and approval of the organization of a public infrastructure district pursuant to subsection

C of this section. The board shall collect the special assessments so levied and use the same to reimburse the public infrastructure district for the amount paid or to be paid by it on the bonds issued for such improvements not to exceed ten (10) mills for the purpose of providing funds for the purpose of support, organization, operation, and maintenance of such services.

C. A public infrastructure district shall not be created unless a petition is filed with the municipality that contains the signatures of one hundred percent (100%) of surface property owners within the applicable area consenting to the creation of the public infrastructure district.

D. The municipality may impose



# "I Was Just Thinkin"

"Does Your Anchor Hold?"

I have a riddle for you. "What do you put down only when you need it, and pick up when you don't need it?"

Give up?

An Anchor!

Many years back we took a vacation to Galveston, TX. The first time was my very first time to see the ocean. It's seemingly endlessness and vastness held me in awe.

Another thing that fascinated me was the 100's of ship's and boats that we saw. There were ships of every conceivable size and description.

I remember being on shore watching a huge shipping vessel go by. I had to lean my head all the way back and look up to see the top of it. On the side was painted, "Dole Bananas".

My mind boggled at how many bananas that would be!! From that massive transport to the smallest craft, no matter how different they appeared they each had one thing in common – they had and needed an anchor aboard.

Should a storm arise or they need to stop they would drop their anchor to secure them and keep from being dashed against the rocks.

I know I have had 'storms' blow into my life that threaten to crush me against rocks. Psalms 47:2 reminds me of such times when I wonder if I may sink.

"Deep calleth unto deep at the noise of thy waterspouts: all thy waves and thy billows are gone over me." In our hearts we know that isn't going to happen but all the noise and the tumult around us take our focus off the fact we have an unfailing anchor in any storm.

"Which hope we have as an anchor

of the soul, both sure and stedfast, and which entereth into that within the veil;" Hebrews 6:19

That of course is Christ, and in many ways He secures and protects us much like a ship's anchor.

Consider this. The size of the anchor appears small in comparison to the size of the ship. When looking at it we might even think. "How can that dinky thing do anything to help such a massive ship in danger?

Yet when times of trouble come it is a life line to safety.

Have you looked prayer, trust in God and faith in that way when gales of tribulation hit your life? They seem too small, too easy, too. . . well, invisible, to really help in such an immense crisis.

In times of trouble these three things have tremendous power, in fact they are link to God's power, inviting Him into the situation to protect and guide His children.


It also protects the ship in a storm from being tossed about and out of control.

safe until he allowed the rage of the storm around him to distract him from who he was walking.

"But when he saw the wind boisterous, he was a fraid; and beginning to sink, he cried, saying, Lord, save me."

It isn't uncommon when a catastrophe strikes for us to panic, when we realize the full extent of what we are facing. We run here and there in a frantic effort to find someone to help or comfort us.

We want relief from the crushing pressure of pain we are experiencing. Just as with Peter, Christ is always there to reach out and calm and steady our racing thoughts and hearts.

The ship feels the tossing of the storm and its fury but the anchor is still there keeping it steady and secure. The anchor does not firmly keep the boat in one location.

The boat moves slightly in the storm but not in such a way that it can be damaged or out of control

Now an anchor isn't only used during those turbulent times at sea. It is also used during times of rest and calm.

When a ship is resting or fishing, it could easily drift off course or into danger. The anchor keeps it right where it needs to be.

Think about the times your life when things are going hunky-dory. Not serious problems, all is going pretty much your way, and you're at ease. This is a dangerous time in a Christian's life and usually they are not even aware of it.

limitations on the powers of the public infrastructure district through the governing document presented by the public infrastructure district applicant.

- E. The levy shall be in addition to all other levies authorized by this Constitution, and when approved, shall be made for the repayment of public infrastructure district bonds issued by the public infrastructure districts for the public improvements agreed upon by the voters of the district as provided by the governing document.
- F. The Legislature shall be authorized to enact such laws as may be necessary in order to implement public infrastructure districts in this state. What will this do?

- 1.Creates more districts to incur debt to private property owners, levied to owner's property.
- 2. Creates a board of trustees you do not vote on. They handle the money.
- 3. Your signature increases property taxes up to 10 mill to your property.
- 4. Creating a new law and section to the constitution.
- 5. Will give legislature permission to create new laws for district-without your knowledge.
- A/ A Yes vote will allow this to be implemented...,more debt, B. No vote will stop the debt, the new laws, stop control of your property.

# Respect Life in its Various Stages and Forms

The young and the old seem to be the most often discarded in our society. Because abortion is so often discussed and so controversial, I would like to further discuss this subject:

#### **Abortion Violates the First Commandment** (Gen. 1:28)

I am not referring to the first of the Ten Commandments, but to the first commandment ever given to man, to multiply and increase in number. God encourages reproduction of people made in His image!

# Abortion Violates the Sixth Commandment (Ex.20:13).

The sixth of the Ten Commandments reads, "You shall not murder." Abortion violates this command.

Severe endangerment of the mother's life is the only possible exception I can ponder. I'd like to add a few comments on this difficult issue:

#### God Is Forgiving

If anyone has gone through the tragedy of aborting a child, God will receive you with open arms if you repent and ask His forgiveness (Luke 15:20; I John 1:9).

#### God Is Just

#### God Is Able

I beg of you before God who gives life, seek help. Don't take the life of your child, but trust God; seek help from us in this congregation. God will help us bear any burden (I Cor. 10:13), and as believers, we are commanded to help you (Gal. 6:2).

#### **Protect Life**

We are not to use violence to push our cause; bombing abortion clinics is just as bad as abortion! Be someone who helps.

Teach biblical truth: the value of human life, and the forgiveness of God.

Support a Christian pregnancy center.

Make sure nursing homes are safe.

Vote against legalization of abortion and euthanasia.

If you're not a part of the solution, you're part of the problem.

# "That Reminds Me

"Dialogue of the Deaf"

Have you ever heard two people discussing something and neither of them seem to understand what the other is saying? It sort of makes you wonder what the problem is.

One day I was counseling a husband and wife. They were both speaking English and using words the other could easily understand. I had no trouble understanding what each was saying. However, there was no communication in their conversation. This is a tremendous example of a "dialogue of the deaf." What's the problem in this case?

The husband was totally logical and unemotional. He said he couldn't see where they had a problem. He had tried to get her to tell him what was bothering her, but she said he just didn't understand.

His wife was operating illogically and emotionally. He handed her a legal pad and a pencil and told her to write down exactly what her complaint was. She said she couldn't do that because she didn't know how to put it into words. She just felt that something was wrong in their relationship.

He finally declared, "Well, I can't help if you won't tell me what's wrong."

She said "I've told you! I don't know what's wrong."

He said, "When you get it figured out let me know. I don't have time to try and guess what's bugging you."

I thought she was going to throw the pad at him. They were on two different wave lengths. Had she thrown the pad, he might have logically known they had a problem.

I recently was reading in the book of Job when Job's friends came to comfort him. Everything was going well in their comforting until they opened their mouth. Then it became apparent even if they

all using were words in the same language, they may as well have been on two different planets.

Job told them what his problem was, but they weren't listening. They were only waiting until he shut up so they could give him their opinion. After several rounds of that Job called them. "miserable comforters." Job 16:2

It seems apparent they didn't even hear that because they continued their rebuke and condemnation of Job.

Had they actually heard what he said they probably packed up their tents and went home. But they hadn't finished what they wanted to say.

It certainly makes it easier to give counsel to someone who is having trouble if we don't have to listen to them. We can make up our own mind what they problem is our modify it so it fits something we can handle. Then we can issue a ruling on how to handle it and get on about our business.

However, if they start talking and we start to really listen, we soon find most problems between human beings aren't simple and easy to solve.

The Bible gives us much more about listening and hearing than about speaking.

James gives us a good rule about speaking in James 1:19.

"Wherefore my beloved brethren, let every man be swift to hear, slow to speak and slow to wrath."

One of the cardinal rules for resolving differences is to listen to the other, not with the intent to respond, but with the intent to understand. Too often in a discussion we are so busy formulating our response we don't listen to what the other is actually saying.

If we truly listen to them, we might find we are both saying and thinking the same thing, but using different approaches and words.

How easy it is to become apathetic, lukewarm and let our relationship with God slip. The tide goes out pulling us further and further to the world and we don't even realize we are moving in that direction.

This is part of our sin nature and God scolds the Israelites for this very thing in Deuteronomy 8:13-14.

"And when thy herds and thy flocks multiply, and thy silver and thy gold is multiplied, and all that thou hast is multiplied;

Then thine heart be lifted up, and thou forget the LORD thy God, which brought thee forth out of the land of Egypt, from the house of bondage;"

Also during times of peace the anchor

is carried on the ship. Always nearby, ready to help at a moment's notice. "...

He hath said, I will never leave thee, nor forsake thee". Hebrews 13:5

The only way to we can be released to move on is retrace our steps back to Him. Back to repentance, prayer, and a close relationship with our Lord that began at the moment we were born again.


No, God doesn't always calm the storm. Sometimes He lets the storm rage, and calms His children. That's when we experience the peace only He can give
